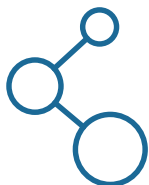
BE AN ADVOCATE FOR YOUR PROFESSION!

Federal elections are an opportunity to ask Canada's current and future political leaders questions about issues that matter most to you. CAOT has created an Election Playbook to help guide your advocacy efforts in the lead-up to voting day. Here are the steps you can take to have your voice heard:



STEP 1 - FIND YOUR LOCAL CANDIDATES

Visit the Elections Canada website, at [ELECTIONS.CA](https://www.elections.ca), to find information about candidates in your electoral district.



STEP 2 - CONNECT WITH YOUR CANDIDATES

- Visit your local candidate's webpage for information on community events and engagements.
- Follow and connect with your local candidates on social media.
- Attend debates and townhalls.
- Call or email your local candidates.
- Engage with your local candidates when they come knocking on your door.



STEP 3 - ENGAGE AND ASK QUESTIONS

Use the brief overviews in this Playbook regarding five current health care issues in Canada, along with the OT value proposition, to engage with your candidates, ask questions and propose solutions. **REMEMBER** – candidates want to hear from YOU as Canada's health care professionals.

LONG TERM CARE (LTC)

THE ISSUE



58%

of COVID-19 deaths in Canada have been residents living in LTC. (NIA, July 2021)

87%

of LTC residents suffer from cognitive impairment. (CIHI, 2018)

90%

of direct care in LTC homes is provided by unregulated and unlicensed care aides or personal support workers. (Royal Society of Canada, 2020)

86%

of Canadians believe that LTC should be an integrated part of our health system and funded and administered accordingly. (NIA, 2021)

92%

of Canadians aged 65 and older agreed that the issues within LTC homes were evident before the COVID-19 pandemic. (NIA, 2021)

THE SOLUTION

Implement national LTC standards that comprise regulated health professionals, including OTs, as essential health care providers in LTC homes.

HOW CAN OCCUPATIONAL THERAPY HELP?

OTs provide cost-effective services for individuals experiencing progressive functional and/or cognitive decline, including complex, chronic, or progressive illnesses. They are the only members of health care teams that focus on the fit between the individual's environment and their strengths and abilities.

OTs assess older adults' health and safety needs with families and interprofessional teams; design and implement customized plans so that seniors can enjoy the highest possible quality of life. They support individuals in restoring or maintaining function and independence using mobility devices, environmental modifications, mindfulness, goal setting and activity routines. OT helps facilitate socially inclusive environments that foster recreational, civic, cultural, leisure and social activities that reduce social isolation.

WHAT CAN CANDIDATES DO IF ELECTED?

- Recognize OTs as primary care providers and include OTs on interdisciplinary health care teams in LTC.
- Fund the implementation of national standards in LTC.
- Ensure that staffing in LTC facilities meets the complex health care needs of residents.
- Work with provincial jurisdictions to secure sustainable solutions to LTC problems.

THE SOLUTION

Include OTs in interdisciplinary primary care teams in communities to support aging in place. Involve OTs in design/build teams to incorporate accessibility and safety features, 75% of these can be included for less than \$500 per home. (Home Modifications Canada, 2017)

HOW CAN OCCUPATIONAL THERAPY HELP?

OTs bring an expert perspective to home modifications so that Canadians can stay home longer and safer. OT interventions related to housing can also postpone entry into residential care, saving up to \$48,000 per year per person (Laing & Buisson, 2008).

OTs support caregivers with skills training re assisting with activities of daily living such as dressing, food preparation and eating, managing aggressive behaviours, thus avoiding caregiver burnout.

OT assists individuals with dementia to safely age in place by: mitigating wandering behaviors; establishing positive routines; promoting health and safety; managing activities of daily living; encouraging social participation and physical exercise.

WHAT CAN CANDIDATES DO IF ELECTED?

- Ensure OTs are part of interdisciplinary primary care teams to support aging in place.
- Increase funding for accessible home adaptation programs, including OT home assessments, to support lower income individuals.
- Have OTs on design/build teams to support home modifications and facilitate seniors aging in place.
- Cover OT in Extended Health Benefits' plans to facilitate aging in place.

What will your party do to include OTs on primary care teams across Canada so that they can provide practical advice on home modifications to individuals facing age-related realities?

MENTAL HEALTH

THE ISSUE



1 IN 5

Canadians will experience a mental health problem or illness in any given year. (CMHA, 2020)

5.3 MILLION

Canadians reported needing help with their mental health. (Statistics Canada, 2019)

6 IN 10 INDIGENOUS PEOPLE

Indigenous people reported that their mental health worsened during the COVID-19 pandemic. (Statistics Canada, 2021)

THE SOLUTION

Increase access to community-based OT services, include OT as part of Extended Health Benefits and fund OT in Indigenous Services Canada's Programs.

HOW CAN OCCUPATIONAL THERAPY HELP?

OTs are essential mental health care providers skilled at addressing trauma, Post Traumatic Stress Disorder (PTSD) and disruptions, such as the various changes brought on by COVID-19.

OTs incorporate a strengths-based approach to help individuals engage in activities that bring a sense of purpose, joy and meaning to their lives. They provide client-centred mental health and addictions services in **homes and communities**.

OTs are uniquely skilled in delivering evidence-based mental health interventions so that Canadians can **get on with the job of living**. OT services include: motivational interviewing; cognitive behavioural therapy; life skills training; mindfulness; stress management; coping strategies; daily routine modification; health, wellness and safety regimes.

WHAT CAN CANDIDATES DO IF ELECTED?

- Ensure OTs are part of interdisciplinary primary care teams to increase access to community-based mental health care in communities across Canada.
- Include OT as part of Extended Health Benefits' plans.
- Work to increase the number of OTs providing services to Indigenous communities, and other underserved or at-risk populations.

THE SOLUTION

Ensure access to OT services by including OT in Extended Health Benefits' Plans.

HOW CAN OCCUPATIONAL THERAPY HELP?

OTs/OTAs assess an individual's functional capacity following a life change and provide solutions for integration back to work while keeping in mind the needs of the employer and employee, resulting in a reduction of lost workdays, increased employee productivity and improved workplace health and well-being. OTs can also facilitate healthy and safe work environment transitions through tailor-made, home modifications.

OTs/OTAs can help rehabilitate those suffering from long-COVID, with lingering physical and/or mental illnesses, through customized individually paced program, where OTs facilitate improvement in function and a therapeutic and **safe pathway for returning to work**.

WHAT CAN CANDIDATES DO IF ELECTED?

- Ensure the inclusion of OTs in interdisciplinary primary care teams treating post-COVID-19 syndrome.
- Increase access to community-based mental health supports, including OT services, for effective return to work transition.
- Include OT in the Public Service Health Care Plan (PSHCP).
- Fund OT in Indigenous Services Canada's programs

THE ISSUE

THE SOLUTION

Ensure all children in Canada have access to OT services by including OTs on interdisciplinary primary care teams in communities across Canada, including rural, remote and Indigenous communities.

HOW CAN OCCUPATIONAL THERAPY HELP?

OTs/OTAs provide a strengths-based approach that helps children with cognitive or functional impairments, assisting in the development of cognitive skills, fine motor skill, gross motor skills (e.g. body coordination), self-care tasks and social skills.

They assess a child's needs and environment to design interventions that help them in progressing through the stages of social and cognitive development, **supporting children's growth and helping them transition to functional, healthy and independent adults.**

Pediatric OT benefits children of all ages as OTs provide culturally appropriate, evidence-based assessment and treatment, using a trauma-informed approach to care to support children, youth and families suffering from trauma and mental health illness.

WHAT CAN CANDIDATES DO IF ELECTED?

- Provide families with government-funded supportive housing, with access to OT services, to help children living with disabilities.
- Ensure funding and access to health care services, regardless of medical diagnosis to ensure that no child gets left behind.
- Integrate OT in Indigenous Services Canada's programs to support children with complex needs and mental health illnesses.
- Include OT in Extended Health Benefits' Plans to ensure families can afford timely and necessary child development care.

QUESTIONS FOR CANDIDATES

How will your party address the significant ways COVID-19 has, and will continue to impact the health and well-being of children and youth?

What will your party do to ensure OT assessments and interventions are accessible to children with disabilities? How will the waitlists & backlogs be addressed?

How will your party support Indigenous families in accessing Jordan's principle funding?
